
and that Administration of all the estate which by law devolves to and vests in

Probate thereof

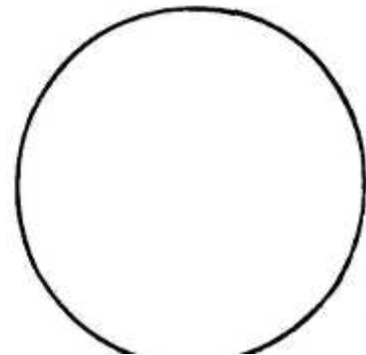

I, FRANK GIBBS of Emohruo of St. Thomas Street Deddington in the County of Oxford Police Pensioner hereby revoke all former Wills and Codicils made by me and declare this to be my last Will

1. I APPOINT my wife ADA and my daughter FRANCES ADA TUSTIAN the wife of Percy Tustian of Buttercombe Farm Swerford in the said County Farmer to be the Executrice and Trustees of this my Will and they or the survivors of them or other the Trustees for the time being hereof are hereinafter called my Trustees

2. I DEVISE my dwellinghouse situate and known as Emohruo St. Thomas Street aforesaid Together with the appurtenances and garden thereto belonging unto my Trustees upon trust to sell the same with power to postpone the sale so long as they shall in their absolute discretion think fit without being liable for loss upon trust to hold the same or the net proceeds of sale as follows :-

(a) Upon trust for my wife Ada for her life she insuring the same and keeping the same in repair.

(b) Upon trust on the death of my wife Ada for my daughter Frances Ada Tustian for her own use and benefit absolutely

3. I GIVE DEVISE AND BEQUEATH all the remainder of my estate both real and personal whatsoever and wheresoever to my dear wife Ada for her own use and benefit absolutely
