Will of William

Williams deceased.

This is the last Will and Testament of me William Williams of Deddington in the County of Oxford Cooper I direct that all my just debts funeral and testamentary expences be fully paid and satisfied by my Executors hereinafter named I give and bequeath unto my Wife Maria Williams the deads year or Executors year in my Copyhold Estate within the Manor of Deddington aforesaid according to the custom of the said Manor for her own use and benefit I give and devise unto my daughter Sarah Bostock Widow All that my Cottage or Tenement and premises situate in Philcocks Street in Deddington aforesaid in which she now resides And also All that my Cottage or Tenement & premises adjoining thereto and now occupied by William Banes To hold to her the said Sarah Bostock her heirs and assigns for ever And I give and devise unto my daughter Eliza Ann Williams All that my Messuage Cottage or Tenement situate in Philcocks Street in Deddington and adjoining to my own dwelling house and occupied by William Bliss. And also all those my four Cottages or Tenements and premises situate in the stile and on Goose Green in Deddington aforesaid and now occupied by Richard Wheeler, John Whelton, Richard Movell, and Richard Saine To hold the same Messuage Cottage or Tenement and the said four cottages or tenements and premises unto my said daughter Eliza Ann Williams her heirs and assigns for ever And I give and bequeath all and every my household goods and furniture linen and wearing apparel, books (except account books and books in my business) plate and china unto my said Wife Maria Williams for and during the term of her natural life and from and after her decease I give and bequeath the same unto my said two daughters Sarah Bostock and Eliza Ann Williams for their own absolute use and benefit in equal shares and proportions And as to all and every my stock in trade and articles of business and also all and every sum and sums of money which may be found in my house or be about my person or be due to me at the time of my decease and also all my stocks funds and securities for money book debts, money due on bonds bills notes or other

securities and all and every other my estate and effects & whatsoever and wheresoever both real and personal whether in possession or reversion remainder or expectancy I give devise and bequeath the same unto my friend Charles Churchill of Oeddington aforesaid Grocer and Butcher and my brother-in-law William Willett of Banbury in the County of Oxford and the survivor of them and the heirs executors and administrators of such survivor Upon trust as soon as conveniently may be after my decease to collect get in and receive such parts thereof as shall consist of money or securities for money and to sell and dispose of the residue of my said estate and effects either by public Auction or private Contract as they my said Executors shall think proper or deem expedient and when and as the same shall come to their or either of their hands Upon trust to lay out and invest the same in their or his own names or name in some or one of the Public Stocks or Funds of Great Britain or upon other security at Interest and to stand possessed of the stocks funds or other securities in or upon which the same shall be invested Upon trust to pay the dividends interest and annual produce arising therefrom unto my said Wife Maria Williams for her own absolute use and benefit for and during the term of her natural life and from and immediately after her decease to pay over or transfer the said Stocks, funds or other securities unto and between my said two daughters Sarah Bostock and Eliza Ann Williams for their own absolute use and benefit in equal shares and in proportions to whom I do hereby give and bequeath the same accordingly And I nominate constitute and appoint the said Charles Churchill and William Willett joint Executors of this my Will And I declare that the receipt or receipts to be given by my Executors or the Trustees or Trustee for the time being of this my Will to the purchaser or purchasers of any part of my real or personal estate or effects or to any person or persons who shall have any of the trust monies in their his or her hands and shall pay the same to the said Trustees or Trustee shall be a sufficient discharge or discharges for so much money as in such receipt or

receipts shall be expressed to be received and that after taking such receipt or receipts the person or persons aforesaid shall not be obliged to see to the application or be answerable or accountable for the misapplication or nonapplication of the same money or any part thereof Provided And that my said Executors ~~be~~ severally and respectively and their several and respective ~~and~~ heirs executors and administrators shall be charged and ~~be~~ chargeable with such sums of money only as they shall respectively actually receive by virtue of the trusts hereby reposed in them notwithstanding their joining in signing any receipt or receipts or doing any other act for the sake of conformity and that they or any of them shall not be answerable or accountable for any misfortune loss or damage which may happen in the execution of the aforesaid trusts or in relation thereto (except the same shall happen by or through his her or their own wilful act neglect or default and in that case each person shall be answerable only for such loss or damage as shall arise from his own act neglect or default) And that it shall be ~~be~~ lawful for my executors herein named severally and respectively and their several and respective heirs executors and ~~and~~ administrators by and out of the monies which shall come to their hands by virtue of the trusts aforesaid to deduct retain and reimburse to and for himself and themselves respectively and also to allow to each other all costs charges damages and expences which they or any of them may sustain or incur in or about the execution of the aforesaid trusts or in relation thereto In witness whereof I the said William Williams the Testator have to this my last Will and Testament contained in three sheets of paper set my hand and seal this seventh day of July in the year of our Lord one thousand eight hundred and fifty six.
