

King's Arms and Edward Hatten

The principal public house in Deddington during the period 1820-1837, which also had the advantage of being a coaching inn, continued to be the King's Arms (now the Deddington Arms Hotel) in Horse Fair, although perhaps less dominant than previously later on in the period on account of competition from the Unicorn.

The King's Arms also enjoyed the status derived from being the venue for the Wootton North Division Petty Sessions (or Magistrates' Court). The 'Bench' used to meet in a small room on the first Saturday of each month.¹

The proprietor since 1806 was Edward Hatten, when he married Mrs. Ann Bilson, the widow of the previous licensee, George Bilson, who had died in 1804. Edward Hatten continued as proprietor of the King's Arms for the subsequent fifty-two years until his death in 1858, aged 84.

Hatten was to become a significant man of business and a leading member of the local community. Amongst other things, he was also a substantial farmer. In 1827 he relinquished part of his farm (unidentified), selling some of his live and dead farming stock (including 23 cows, 370 sheep, 2 horses, 4 fat pigs). In 1834, on his leaving Leaden Porch Farm (over 150 acres), there was an extensive sale of livestock.

Edward Hatten also acted as land agent and surveyor for the leading local solicitor, Samuel Churchill, until his bankruptcy in 1827 (see [Churchill's bankruptcy](#)), buying, selling and letting farms and dwelling houses on behalf of his principal. Churchill had inherited 369 acres in the Parish from his father on his death in 1808, and he also held extensive leasehold property.

Through the King's Arms, Hatten was also involved with Samuel Churchill in the hiring of horses, chaises and special messengers. When Churchill was declared bankrupt, Hatten was the second largest local trade creditor, being owed £1,406 17s. In his proof of debt, he described himself as 'gentleman'.

As regards public positions, Hatten was an agent for the County Fire Office and Provident Life Office from 1818 to 1831. Already one of the Chief Constables of the Hundred of Wootton, in 1819 he was appointed Examiner of Weights, Balances, and Measures, in the North Division of the Hundred.

Although the King's Arms appears to have been facing strong competition from the Unicorn (landlord John Sturch) from the late 1820s, this seems to have been checked by the installation of John Herring as tenant landlord in 1836. His catering for the cricket club, yeomanry, North Oxfordshire Conservatives and manorial court (two of the dinners off-site) drew favourable comments. Previous tenant landlords have not been identified.

Apart from being a hostelry, the King's Arms was also a coaching inn. Hatten commenced the 'posting business' in 1813. An advertisement in 1820 announced that 'The Regulator' mail coach to London would start at the King's Arms. The 'Tally-Ho' was advertised as calling at the King's Arms in 1835. A new light coach, 'The Railway', started a daily road and rail service (Sundays excepted) from the King's Arms to Snow Hill in the City of London in 1837.

In Robson's Commercial Directory in 1839, the King's Arms was described as a commercial inn and posting house.
