Fee or Fees thereof, by the rents & services thereof due & of right accustomed AND the said Richard Jakeman for him selfe his heires and Assignes & every of them doth Covenant and grant to & wlith the said William Sturch his heires & assigns by these ploinlts That at the ensealing & delivery hereof he now standeth lawfully seized of and in the said Tenement & all and singular other the before bargained p[re]misses & every p[ar]te & p[ar]cell thereof w[i]th their appurtenances of and in a good sure p[e]rfect absolute & indefeasible estate of inheritance in Fee simple or Fee taile generall wilth the remainder & Mortgage or Contingency or other limitation of use to alter, change, or discontinue the same And that he the said Richard Jakeman hath good right full power & lawfull authority in his own right only to give graunt bargaine sell alien enfeoffe & confirm the before bargained p[re]misses and every p[ar]te and p[ar]cell thereof with the app[ur]tenances unto the said WILLIAM STURCH his heires & Assigns for ever AND the said Richard Jakeman for him selfe his heires and Assignes doth Covenant and graunt to & with the said William Sturch his heires & assigns & every of them by these p[oi]nts that he the said William Sturch his heirs & assigns & every of them the before bargained p[re]misses and every p[ar]te and p[ar]cell thereof w[i]th the app[ur]tenances from time to time & at all times hereafter forever quietly & peaceably shall and may have hold possess and enjoy cleare & free, & clearly & fully & absolutely freed discharged & by him the said RICHARD JAKEMAN his heires or Assignes well and sufficiently saved harmelesse & indemnified of & from all and all manner of former & other bargaines sales gifts grants Leases, Joyntures, Dowers, Wills, Intailes, Fines, forfeitures, All debts upon record, Verdicts Judgements Executions And also of & from all other charges titles troubles and incumbrances whatsoever heretofore had made committed acknowledged & done by him the said Richard Jakeman his heires or Assignes or by any other Pferlson or pferlsons whatsoever lawfully having or claiming or whilch hereafter shall or may lawfully have or claime any manner of lawful Estate out of, in, or to the before bargained pfrelmises or any pfarlet or pfarlcell thereof By through or under him them or any of them their or any of their rights titles estates or Interests (The rents & services hereafter to grow and become due or payable to the chiefe Lord or Lords of the Fee or Fees thereof only excepted, and forprised) AND the said Richard Jakeman for him selfe his heires or Assignes and for every of them doth Covenant and graunt to and with the said William Sturch his heires and assignes and every of them by these p[re]sents that he the said Richard Jakeman his heires and Assignes and every other p[er]son or p[er]sons whatsoever now having or claiming or which hereafter shall or may have or lawfully claime any manner of lawfull Estate out of in or to the before bargained p[re]misses or any part or plar lcell thereof by through or under him or them or any of them, their or any of their rights estates or interests from time to time and at all times hereafter for & during the space of Twenty years next ?ensuing the date hereof At? ?? reasonable requests and at the only costs & charges in the Law of him the said William Sturch his heirs or assignes or of some of them, shall and will doe make suffer acknowledge ??auy execute p[er]forme conclude and finish or cause to be made done acknowledged leavied executed p[er]formed concluded & finished All and every such other and further lawfull Act & Acts, thing & things, devise and devises, conveyance and assurance in the Law whatsoever for the better assuring plerlfecting surety, and sure making and conveying of all the Before bargained p[re]misses and of every part and p[ar]cell thereof unto the said William Sturch his heires and Assignes for ever, Be it by Fine Feoffment or recovery w[i]th single or double Voucher or Vouchers, deed or deeds, inrolled, the [inrollment of these p[re]sents, Release, Confirmation or otherwise, By all those waves or meanes or by any or so many of them or by any other meanes as by the said William Sturch his heires and Assignes or by some of them or by his or their Counsell learned in the Lawes of this Realme shal be reasonably and lawfully advised devised and required, so as the said Richard Jakeman or his Assigns so requested (to make such further assurance) or any of them be not compelled to travel above Thirty miles from the place of his or their usual aboad at the time or the making of such request for doing thereof IN WITNESS whereof the said RICHARD JAKEMAN to this p[oi]nt Indenture hath sett his hand & seale the day
