#### 28 June 1755

Notice of meeting at the Crown and Tuns, Deddington (John Davis), of the Commissioners for the repair &c. of the roads between Adderbury and Oxford.

Notice is hereby given,

THAT the Commiffioners appointed for putting in Execution an Act of Parliament for Repairing, Amending, and Widening the Roads leading from the Guide Poft at the Village of Adderbury in the County of Oxford, to the Mile-way near the City of Oxford, in the faid County, intend to Contract for the Repair of the faid Road, at a certain Price by the Mile; and for that Purpofe will meet at the Houfe of John Davis, at Dedington in the faid County, being the Sign of the Crown and Tuns, on Monday the Seventh Day of July next, when and where all Perfons inclined to undertake the fame, may deliver in their Propofals. And the Commiffioners will then and there tranfact all other Matters relative to the faid Act.

### 23 August 1766

Notice of proposed alterations to the Banbury to Aynhoe and the Banbury to Deddington Turnpike Roads pursuant to Adderbury Inclosure Act.

BANBURY, Auguft 12th, 1766.

NOTICE is hereby Given, That purfuant to an Act of Parliament made in the laft Seffion of Parliament, intituled, "An Act for "Dividing and Inclofing certain Open and Common Fields and "Commonable Lands in the Parifh of Adderbury, in the County of "Oxford:" We, the underwritten Commiffioners, appointed to put the faid Act in Execution, by and with the Confent and Approbation of five of the Commiffioners for the Turnpike Road leading from Banbury to Aynhoe, and of five of the Commiffioners for the Turnpike Road leading from Banbury to Deddington, have fet and ftaked out the Alterations intended to be made in the faid refpective Turnpike Roads, to the Intent that any Perfons who may think themfelves aggrieved

thereby, may be heard touching the fame, before fuch Alterations are made final at the next Meeting of us the faid Commiffioners, to be held at the Three Tons in Banbury, on Tuefday the Second Day of September next, at Eleven o'Clock in the Forenoon.

N.B. The Road from Deddington to the Turnpike Road in Aynho, leading to Brackley, Buckingham, &c. is now compleated, and made a fafe and commodious Road; and the whole of the Road leading from Deddington to Chipping-norton is much repaired, and will be very fafe for Carriages all the summer.

The Oxford Turnpike Road, extending from the South Side of Deddington, in its prefent Courfe, to Deddington Turnpike.

The Banbury Turnpike Road, extending from the North Side of Deddington, in its prefent Courfe, to Adderbury Bridge.

The Chipping Norton Turnpike Road, extending from the Weft Side of Deddington, in its prefent Courfe, until it enters the Parifh of South Newington.

And, The Aynho Turnpike Road, extending from the Eaft Side of Deddington, in its prefent Courfe, to the Village of Clifton.

# 5 November 1850, North Oxfordshire Monthly Times [transcript] DEDDINGTON PETTY SESSIONS.

SATURDAY, OCTOBER 5th, 1850.

Present - C.C. Dormer, Esq., the Rev. S.Y. Seagrave, and J. Lechmere, Esq.

IMPORTANT TO DOG CART OWNERS. - Busby, the keeper of the Deddington Gate, enquired if he was justified in insisting on the payment of toll for dogs drawing carts, &c., along the road. The Magistrates were of an opinion that dogs were liable to payment, and that the collector was justified in demanding it. Carts so drawn are frequently without the owner's name on them. The Clerk was of an opinion that the omission made the owner liable to the penalties of the Act, viz., to the payment of a fine of £5.
