Feoffees, several of whom have moved from Deddington, partake of dinners at the expense of the charity, which they have no right to do. Also claimed Mr. Henry Dean renting land from feoffees at a lower rate than the rent charged to poorer tenants. Charity managed by "two or three", while majority of trustees unaware of proceedings.
