King's Arms Inn

At the beginning of the 19th century the landlord of the King's Arms (today the Deddington Arms Hotel) in Horse Fair was George Bilson, who had become the licensee in 1795. On his death in 1804 his widow Ann took over the keeping of the inn until, in 1806, she married Edward Hatten, a baker.

Edward Hatten continued as landlord of the King's Arms for the subsequent fifty-two years until his death in 1858, aged 84. Hatten was to become a leading member of the local community.

He became an agent for the County Fire Office in 1818, and for the Provident Life Office in 1819. Already one of the Chief Constables of the Hundred of Wootton, in 1819 Hatten was appointed Examiner of Weights, Balances, and Measures, in the North Division of the Hundred.

The below analysis of the references to the King's Arms 1800-1819 demonstrates its dominant position amongst the public houses in Deddington. Out of 57 auctions on licensed premises in Deddington during this period, 44 were held at the King's Arms, and it was the venue for various public meetings.
