Deddington Inns

The public houses in Deddington were the focal point of much social and business activity, the only other roofed buildings with public access being the parish church and the Town Hall.

Auctions of property, if not on the premises (e.g. farm equipment, furniture), were normally conducted at one of the public houses, predominantly at the King's Arms.

All 6 of the principal inns in Deddington changed hands during the period under consideration:

- 1806 Unicorn (to be let on retirement of William D'Oyley as landlord)
- 1806 King's Arms (Edward Hatten married widowed landlady, Ann Bilson)
- 1807 Crown and Tuns (Tuns Inn to be let following death of Thomas George)
- 1811 The Plough (freehold for sale; landlady, Mrs. Goodman, retiring)
- 1815 Three Horse Shoes (freehold for sale following bankruptcy (1814) of landlord, William Malings)
- 1816 Red Lion (unexpired lease for sale following death of landlady, Mrs. Bennett (probably widow of William Bennett, landlord 1780, 1806), and bankruptcy of Thomas Bennett)

A list of the references to inns in Deddington mentioned in *Jackson's Oxford Journal* during the years 1800-1819 is set out below.¹

King's Arms, Horse Fair

Red Lion, Horse Fair

The Red Lion Inn was apparently a building of some antiquity in Horse Fair (or Red Lion Street in 1771), before moving to its present site in Market Place which was a farmhouse until the mid-19th century.²
