On Tuesday last the annual meeting of the Banbury, Chipping-Norton, and Deddington District Committee of the Society for Promoting Christian Knowledge, was held at Deddington, G.F. Stratton, Esq. President, in the chair. The Sub-Committee reported that 1071 prayer-books, 340 bibles and testaments, and 1796 other books, had been sold in the last year, making a total of 4369 prayer-books, 1458 bibles and testaments, and 8340 other books, in six years. A donation of 20*l.* was voted to the society, in aid of its general designs, (in addition to 45*l.* remitted to it as one-third of the sum paid for books received, according to its regulations); making a total of 764*l.* 10*s.* 10*d.* remitted for books, and 272*l.* 10*s.* free, since the formation of the committee in 1819.

On the evening of Monday the 19th of September, a Meeting was held, according to previous notice, in the Parish Church of Deddington, when an Association was formed and subscriptions were received in aid of the benevolent purposes carried on by the Church Missionary Society for Africa and the East. G.F. Stratton, Esq. having been called to the chair, the Meeting was addressed by the following clergymen:- Messrs. Greaves, Boddington, Wilson, Bickersteth, Newman, Browne, Woodroffe, Mayers, Hughes, and Hill; and also by Mr. Joseph Greaves, late from Malta, one of the spheres of the Society's labours. The Rev. E. Bickersteth, Secretary to the Parent Institution, furnished copious accounts of its rise and progress. Having personally visited one of the most interesting of its stations, that of Sierra Leone, on the west coast of Africa, the Rev. Gentleman was enabled to give full details both of the difficulties and success attendant upon the endeavours in that quarter. The attention of the Meeting was thoroughly engaged by the different addresses, during the whole time of its continuance, and the impression left was highly favourable to the cause of the diffusion of our holy faith. As this Association is designed as a channel for the Christian benevolence of the whole of the Northern division of this county, it is earnestly hoped that it will meet with general countenance and support from the inhabitants of the North of Oxfordshire.

A Meeting of the Trustees of the Burford, Chipping-Norton, Banbury, Stow, and Aynho Turnpike Roads, was held at the White Hart Inn, at Chipping-Norton, on Tuesday last, for the purpose of appointing a Clerk or Clerks to the Trust. There were present sixty-three Trustees, including fourteen Justices of

the Peace for the counties of Oxford, Northampton, and Gloucester. Lord Churchill having been called to the chair, the business of the day was opened by William Ralph Cartwright, Esq. M.P. of Aynho, who proposed that a Clerk be appointed for the Aynho Division (extending from Swerford Gate, through Deddington to Aynho) separate from the other parts of the Road. This proposition was seconded by Colonel Perrott, of Sandford Park, and being opposed by A.T. Rawlinson, Esq. of Chadlington, was put to the vote, when the proposition was carried by a majority of 38 against 22. It was then moved by Mr. Cartwright, seconded by Colonel Perrott, that Mr. Field, of Deddington, be Clerk to the Division, which was agreed to unanimously, and Mr. Field was declared elected. James Haughton Langston, Esq. M.P. of Sarsden House, then proposed Mr. A.L. Rawlinson, solicitor, of Chipping-Norton, as Clerk for the Burford, Banbury, and Stow Divisions, and the General Meetings, which was seconded by T.B. Evans, Esq. of Dean. And the Rev. R.W. Ford, of Rissington, proposed Mr. Aplin, solicitor, of Chipping-Norton, and Mr. Wilkins, solicitor, of Bourton-on-the-Water, as Joint Clerks for these Divisions, and the General Meetings: this was seconded by the Rev. Charles Western, of Kingham, and a division took place, when the numbers were for Messrs. Aplin and Wilkins 31, and for Mr. Rawlinson 27; Messrs. Aplin and Wilkins were then declared duly elected.
