Charles Gibbs of Deddington in the County of Oxford
formerly an Inspector at Parade Street Station, London. I appoint
my Brother Samuel Gibbs of Deddington aforesaid Retired Shoemaker
to be the sole Executor hereof and I give and bequeath unto
my Daughter Edith now living with me all my household
furniture and personal effects of every description together with
any money which I may have invested in my name or deposited
by me in any Bank with the free use and enjoyment of the
dwellinghouse and premises situate in Philcott Street or St Thomas's
Street in Deddington aforesaid for many years belonging to me and
now in my own occupation so that she may reside there when not
living there that she may receive the rent of such dwellinghouse
for her own use and benefit she keeping the same in tenantable order
and repair and insured against loss or damage by fire but that
she is not to dispose of such dwellinghouse by sale or otherwise
and at the death of my said Daughter Edith it is my wish that
the said dwellinghouse and premises shall become the property of
my Nephew Frank the only Son of my said Brother Samuel Gibbs
and to whom I devise the same accordingly and I direct that my
just debts funeral and testamentary expenses shall be paid and
satisfied as soon as conveniently may be after my decease. In witness
whereof I have hereunto set my hand this twenty third day of December
One thousand nine hundred and fifteen.
