

THIS DECLARATION OF TRUST is made the 17th day of FEBRUARY 2017
BY **NORMAN WEST** of 22 The Green North Aston Bicester Oxfordshire OX25
6HX **ROBERT STANLEY FORSYTH** of The Stile House New Street Deddington
OX15 0SR and **PAUL RAYMOND TEASDALE** of StoneCroft Clifton Road
Deddington OX15 0TP ("the Trustees")

WHEREAS

- A. BY a Deed of Declaration of Trust made on the 30th day of November 1925 ("the Trust Deed") William Joseph French Bryan Worsley Millington Thomas William Turner and Harry Douglas Hopcraft declared that they would hold the property described in the Schedule hereto upon the trusts therein declared
- B. THE said Trusts were declared in Clause 1 of the Trust Deed
- C. CLAUSE 2 of the Trust Deed provided that if the Deddington Branch of the British Legion ceased to exist then the Property would be held in Trust for the Parish Council of Deddington for and on behalf of the inhabitants of the Parish of Deddington
- D. THE Trustees are the current Trustees of the Trust Deed
- E. A Resolution was passed at a General Meeting of the Branch Members of the Deddington Branch of the Royal British Legion on the 28th January 2017 and the Trustees are desirous of amending the Trusts of the Trust Deed in accordance with that Resolution

NOW THIS DEED WITNESSETH as follows:

1. IN pursuance of the said Resolution the Trustees hereby declare that Clause 2 of the said Trust Deed dated 30th November 1925 shall be amended to provide that the Trustees of the Hereditaments and Premises shall, in the event of any of the conditions contained within Clause 1 of the said Deed being breached or incapable

2. THE Trustees hereby declare that they hold the said property upon the trusts declared in the Trust Deed as amended by this Deed
