Bankruptcy 1827-1867 of Samuel Churchill, solicitor (died 1840)

19 February 1828 Minutes of examination of SC. The financial schedules and accounts A to Z produced by the Bankrupt for the Assignees not with court file.

SC questioned as to why he conveyed unencumbered property to trustees in July 1826. He said it was his own idea, under advice from Mr. James [solicitor] and his brother [Benjamin]. The purpose was to raise money. It was more efficient than individual mortgages or sales.

SC was questioned about legal proceedings and executions by creditors current at the time of executing the trust deeds. SC's debts were recorded in ledgers or bill books.

Trustees raised some money by mortgages to discharge debts due to 'urgent' creditors. SC thought his debts amounted to at least £50,000 in July 1826. He must have had some statement of his property and debts, although he could not now recollect it.

Under further questioning about the extent of his debts, SC was vague, initially saying £50,000 to £60,000. He believed a list of debts was delivered at the time to Mr. James.

20 February 1828 Continuing examination of SC. Questions about the schedules and accounts which he had prepared for the Assignees.

SC believed that:

- his freehold estates were worth at least £50,000 in July 1826;
- he also held 'collegehold' [i.e. leasehold] estates worth £10,000 at the time.

SC was also entitled to his share in the partnership of Churchill and Field, including various amounts not yet billed.

SC could not be more specific about quantifying his share in the partnership assets in July 1826 as Mr. Field's interest was not yet settled. He was probably entitled to £2,000 or £3,000 alone.

SC's other property in July 1826 comprising his household furniture, horses and carriages was sold at auction in July 1827. The net proceeds were about £1,400.

Questioning then turned to SC's interest in the partnership of Churchill and Field. No accounts had been drawn up for 25 years. SC thought his share was worth nearer £10,000 than £5,000. Some £4,000 or £5,000 was probably owing to the partnership. There were no other firm assets apart from the house now occupied as offices by Mr. Field.

As to whether SC was insolvent when he executed the indentures on 17 and 18 July 1826, he had "no such idea", but he now believed that he was insolvent.

Minutes of examination at Alice's Coffee House, Westminster, on 10 November 1828, of Joseph Buckingham of Steeple Aston, servant to Mr. Hitchcock [solicitor], previously servant to SC from 1 January 182[1] to June 1827.

SC away from home for 9 weeks from mid-February 1826. Mr. James James (SC's solicitor) and brother, Mr. Benjamin Churchill, present on several occasions when SC told Buckingham to say 'Not at home' to creditor's servant.

Another creditor also frequently called for money.

Mr. James frequent visitor.

SC's cousin John Churchill also kept visitors at bay.

Escape of SC from sheriff's officers from Oxford via Aynho to London.

Creditors complained SC never at home when they called or did not keep appointments.

The foregoing was the subject of general observation in the neighbourhood.

Sheriff's officer stayed in the house for several months to mid-August 1826 levying execution on SC's effects.

138 - 139.

Minutes of examination on 11 November 1828 of William East, a Quaker.

East was SC's clerk 1796 to 27 March 1827.

SC was considerably in debt, and could not meet his payments when they fell due in 1825 and 1826.

Regarding SC's lack of funds to pay the legacies under Mary Henshall's will:

- unsuccessfully tried to borrow money;
- avoided 2-day meeting in March 1826 at the Fox Inn, North Aston;
- disappeared 9 February to 9 April 1826.

Directions to East to prepare discharges for legacies originally came from SC's brother, John Churchill.

James James of Aylesbury a friend and relation of SC, rather than his solicitor.

140 - 141.

Continued examination 13 November 1828 of William East.

Without explanation Mr. James threw the deeds of SC's own properties into a large sack and took them away in a chaise. No inventory or list was prepared.

5 creditors or their servants called whilst SC was absent 9 February to 9 April 1826.

Letters forwarded to an anonymous forwarding address.

Mr. James and Benjamin Churchill in house 3 days in July 1826 when executions took place.

SC absent several times totalling 2-3 weeks 9 April - 18 July 1826.

Minutes of examination on 13 November 1828 of John Churchill of Deddington, brother.

SC had expected a loan to fund the payment of the legacies unpaid to the Pearsons under Mrs. Henshall's will.

Sheriff's officers in house 2-3 months in mid-1826.

SC executed the deeds of trust on 17 and 18 July 1826 to raise money.

Mutual releases by SC and brother on 13 July 1826 related to the deeds of trust.

SC sought release from £8,000 legacy due to brother under father's will [died 1808].

John Churchill non-committal about whether on balance he was in debt to SC, but "I dare say I may have been indebted to my brother".

148 - 150.

Minutes of examination on 14 November 1828 of John Churchill of Castle Street, Deddington, first cousin.

Place of business Bartlett's Buildings in City of London.

SC sought his advice in February 1826 following dissolution of his partnership with Samuel Churchill Field, whilst he was absent from Deddington.

Deponent took part in negotiations between SC and Mr. Cooper of Henley to borrow a considerable sum secured by mortgage, which fell through in April 1826.

Cousin continued to advise him since then.

Many absences by SC April to June 1826, but not for any length of time. It was his custom to ride out on his horse almost daily during the hours of business.

Deponent spent time in SC's house; Churchill played down visits by creditors.

Cousin asked creditors to call again, referring callers to William East, SC's clerk.

151 - 155.

Further examination of John Churchill, first cousin, on 18 November 1828.

At least 4 other law suits April to June 1826.

In June 1826 it was proposed to transfer SC's assets to 4 trustees, Mr. Shallow, Rev. Mr. Gordon, Rev. Benjamin Churchill and James James, but the measure went off.

Cousin present when Mr. James removed SC's title deeds in a sack in July 1826. No schedule drawn up at the time.

SC executed deeds of trust on 17 and 18 July 1826. Cousin not present.

On 9 November 1826 a Sheriff's officer called Shepherd came in a post chaise with an arrest warrant for SC and to take him to Oxford gaol, in company with Charles Pearson, one of Mrs. Henshall's legatees.

Deponent told officer SC ill in bed, and sent his servant for Mr. Turner, surgeon.

Cousin sent another note to SC's wife to get SC out of house to Aynho in neighbouring Northamptonshire.

SC escaped by back door through the garden. Cousin subsequently walked with SC to Aynho, from whence he took the mail coach to Aylesbury.

Deponent not present when SC, Mr. Benjamin Churchill and Mr. James executed securities to Lord Carrington, Mr. Greenwood, Mr. Crouch, Mr. Brundrett, Mr. Borton, Mr. Jackson and Mrs. Rolls [executrix of Mrs. Mary Weston].

5 legal actions pending on 17 July 1826, one for £7,000, which secured.

Rev. Mr. Benjamin Churchill was SC's brother.

Cousin approved of SC's conveyance to trustees. Purpose to raise money, and to settle his affairs by selling such properties as was necessary.

Deponent did not consider impact of such a conveyance on current legal actions or executions, although this may well have been the objective.

Did not believe SC committed act of bankruptcy in June 1826.

Cousin and James discussed the possibility of SC going to gaol in February or March 1827.

Trustees of proposed deed of trust were Rev. B. Churchill and Mr. James.

In letter to SC, cousin said "Carrington mortgage good". He could not now remember what he meant by this.

156 - 158.

Minutes of examination on 24 November 1828 of James James of Aylesbury, gentleman, at Alice's Coffee House, Westminster.

SC and the Deponent had married sisters.

Mr. James had had no transactions with SC before July 1826, when it was suggested that he might help to raise money for the bankrupt.

At the time SC was seeking to raise £20,000 on security from Mr. Cooper, a Henley solicitor, who already had secured dealings with SC.

Mr. Cooper said SC had had a fall from his horse which much injured his health.

Mr. Cooper advised SC to give up business and let friends settle his affairs.

Mr. James acted as SC's solicitor in these transactions.

SC said that £15-20,000 would answer all his purposes.

SC told the Deponent he was a sick man.

SC said his property was yielding £2,000 a year rental income.

Mr. Cooper told Mr. James that SC had not sent two releases for legacies payable to his two brothers under their father's will [1808] and thereby charged on his real property.

The Deponent told SC that if he raised any money, he would need SC's freehold properties to be conveyed to trustees to avoid giving individual powers of sale to lenders.

SC accordingly conveyed the real property to James James and Mr. Benjamin Churchill [brother] as trustees on 17 and 18 July 1826.

The two trustees then raised £5,000, part paid to Mr. Cooper in discharge of executions.

SC had issued a statement in writing that his property was worth £30,000 after payment of debts. Mr. James thought this was in July 1826 before the execution of the trust deeds. He believed it to be correct at the time, but not now given the declaration of bankruptcy. Whereabouts of statement not known.

On the basis of a rental income of £2,000 a year, the Deponent believed SC to be a rich man. A local solicitor, Mr. Lock, said he could get him a secured loan of £20,000 to £30,000.

159. Accounts of SC's trustees, Benjamin Churchill and James James, for 2H1826, settled 31/1/1828. Footings £6,113 8. 4.

Further examination of James James on 24 January 1829 at Alice's Coffee House, Westminster.

Deponent raised £5,000 from Lord Carrington in August 1826.

Explanation of above accounting entries.

Mr. James prepared a general charge over SC's property to Mr. Brundrett of the Temple in January 1827.

Deponent prepared several mortgages to Mr. Borton and Mr. Jackson in January 1827.

Title deeds of Clifton estate had been deposited with Borton and Jackson in 1823 to secure advances.

164 - 168.

Further examination of James James on 26 January 1829.

SC owed £500-600 for legal fees to Deponent, who claimed a lien over SC's deeds. He declined to apportion the fees between the trust deeds and defending actions.

Several deeds by way of security executed in January 1827, to prevent judgments being executed on SC's property.

£2,000 judgment debt to Mrs. Keziah Greenwood. Following negotiations with her solicitors, Messrs. Baker and Hodgson, the parties executed a general charge in January 1827 although it was antedated 27 October 1826 when it was first mooted.

Questioning whether purpose of the two deeds of trust was to disadvantage creditors.

Mr. James said he was only generally aware of other creditors. He did not consider whether they might be prejudiced by the deeds of trust. He declined to swear positively that he never said the deeds would be an impediment to enforcement proceedings by creditors.

169 - 175.

Further examination of James James on 27 January 1829.

Detailed questions about the preparation and execution of the above general charge to Mrs. Keziah Greenwood.

The Deponent denied knowledge that SC instructed his servant to tell callers he was not at home.

Mr. James sought professional advice from a Conveyancer as to the propriety of the trustees in executing a general charge to Mrs. Greenwood.

£5,000 and £100 were received under the trust deeds. Other sums for which securities were executed by the trustees were for debts previous to July 1826.

Deponent also acted for Lord Carrington and declined questions about that transaction.

In October 1826 Mr. James persuaded Mr. Brundrett not to enforce his judgment as the Deponent had a promise of £10,000 upon the security of the trust property by Christmas, and if that did not materialise the trustees would execute a charge over the trust assets.

The charge in favour of Mr. Brundrett was not executed until January 1827 although it was antedated the date in October 1826 when Mr. Brundrett agreed to accept the security.

As regards SC's Clifton estate, the deeds had been deposited with Mr. Borton and Mr. Edward Jackson to secure a loan by them, but in March 1826 they had lent the deeds to SC to enable him to prepare proper security documents. The issue was raised with Mr. James in September 1826 who, after obtaining SC's confirmation, completed the securities.

No documents executed under trust deeds after January 1827 except that to Mrs. Rolls [executrix of Mrs. Mary Weston].

Mr. James had been seeking to prevent executions of SC's estate by granting security to specific creditors.

The Deponent at first refused to answer questions whether SC left home to avoid arrest on 9 November 1826. He then admitted that he had been summoned to Deddington House the following day.

As regards the judgment obtained by Mrs. Rolls for a loan in 1824 secured by mortgages over land at Barton and SC's dwelling house in Deddington, which was part of the property comprised in the trust deeds, to avoid execution, following negotiations begun in October 1826, Mr. James agreed to provide further security. Deeds were accordingly executed, by the Deponent in March 1827, although they were antedated.

Security for £700 was also given to Mr. Crouch, as trustee for Mr. Hanley, when the latter advanced £100 to SC, in addition to an existing unsecured loan of £600. The deed, which was antedated, was executed by Mr. James in December 1826.

The Deponent also acted as solicitor for Lord Carrington, Mr. Edward Jackson, Mr. Henry Borton, Mr. Crouch and Mr. Brundrett.

William East of Clifton died 1814, leaving a widow, Elizabeth, 6 sons and 1 daughter. 21 year lease of lands in Clifton from Dean and Canons of Windsor. Elizabeth East continued farming business, and deposited profits totalling £1,685 with SC for account her late husband's estate as follows:

Monies to be held by SC to pay the 'fine' for the renewal of the lease. Transpired several years later in June 1827 that SC had neither paid the 'fine' nor renewed the lease. SC had misappropriated and converted to his own use the sums deposited with him. When discovered, the 21 year term had nearly expired.

In September 1822 John Gardner married Elizabeth East. Following SC's bankruptcy in March 1827, John Gardner agreed to procure the renewal of the lease and pay the 'fine' out of his own pocket, as well as paying to William East's children the sums they would otherwise have received under their father's trust.

William and Elizabeth's children were John East, William East, Henry East, James East, Thomas East, Robert East and Mary East.

John Gardner paid the £600 legacy to William East's children when the youngest attained 21, although son William had pre-deceased.

Of the 4 original trustees:

- James East died shortly after the death of the testator;
- John Stilgoe died 1839;
- SC died 1840;

- John Gardner died 1850.

Joseph East (otherwise Gardner) was the illegitimate son of John Gardner and Elizabeth East before they married.

On 3 September 1846 John Gardner settled assets in family trust. beneficiaries wife, Elizabeth, and then Joseph East and William Gardner. Elizabeth pre-deceased John Gardner, who died in April 1850. Accordingly, William Gardner entitled to £1,685 deposited with SC and 5% interest, upon trust for Joseph East.

Corresponding claims against SC transferred to John Gardner. Deponents' brothers James East and Thomas East live considerable distance from Deddington. Brother Henry East, sister Mary Stilgoe and husband John Stilgoe, now dead.
