### **5 December 1850, Banbury Guardian**

Densely crowded meeting concerning the "Papal aggression" in Girls' Schoolroom. Chairman, Rev. W. Wilson, curate, supported by Rev. F.G. Wilson and Rev. G. Venables, assistant curates. Opening statement by Rev. W. Wilson. All inhabitants asked to sign address to the Queen, drawn up by Rev. J. Brogden, vicar. Also asked to sign a separate Protest against Tractarianism [Oxford Movement]. On enquiry by Mr. [Charles] Faulkner, one of churchwardens, what was to be done with the Protest once signed, Rev. W. Wilson said it would be kept at the school.

Mr. Faulkner proposed following addendum to the Address: "*And your petitioners (or memorialists) look with alarm at the introduction of Puseyism, Tractarianism, and error into the teaching and worship of the Established Church. We, therefore, implore that your Majesty will be pleased to direct that such measures may be adopted as may remove and prevent such injurious practises.*" Addendum carried by acclamation. Further comments by Mr. Faulkner, and by several Non-conformists. The utmost unanimity prevailed the whole of the time.

Inquisition by a Commission of Charitable Uses in 1611 listed 6 charities for the payment of fifteenths [tax on moveables] and for the relief of the poor, including the Hermitage, and rents from shops and stalls under or adjoining the Town House built with money raised out of the Hermitage.

Decree of Commissioners in 1612, *inter alia*, nominating 12 feoffees, who to account annually to 2 JPs, and specifying terms on which leases should be granted.

1627 Decree by Commission of Charitable Uses, reciting 4 further charitable endowments and various digressions by feoffees from 1612 decree, specifying fresh conditions, including accounting yearly to 3 JPs and the overseers.

£300 paid to feoffees for exchange of land in 1810. Clear annual income of c. £140.

For great number of years before 1818, few sums given to poor people while remainder paid towards poor rate.

New feoffees appointed in 1818. In 1822 feoffees erected alms-houses for 4 poor men and 4 poor women, at cost of £653, leaving indebtedness of £163 4. 2d.

Weekly allowance (costing £72 16s. per annum) paid to almspeople, but no clothing provided because of indebtedness. Report says would be surplus income once debt paid off.

Several communications to *Banbury Guardian* about improper distributions and mismanagement. No response from feoffees. 1823 indebtedness ought long since to have been paid off. Should have been considerable annual surplus.

Accounts not made public or submitted to magistrates and overseers as required by 1627 decree. No clothing provided for almspeople. Dissatisfaction at secrecy and mode of management. Case to be submitted to the Attorney-General.

Extended report on new attempt to fill in the insanitary pool in Market Place, proposed to be replaced by a well which could be retained as a reservoir in case of fire, promoted by Mr. John Calcutt. Initiative prompted by recent cleansing of the pool. Well-attended Vestry meeting, chaired by Rev. Brogden, voted on 3 propositions. Largest vote in favour of *status quo*. Mr. C.D. Faulkner demanded a poll of all ratepayers, in which maintaining the *status quo* prevailed because of the multiple votes (up to 6) cast by landowners (e.g. farmers). Alleged that some votes illegally cast by ratepayers who had not paid their poor's rate. During the poll several farmers "looking at the list of those who had voted, made use of very illiberal language, because these persons had voted against their (the farmers') views."

Mr. Calcutt demanded a scrutiny of the votes, but the Vicar refused, saying he should take counsel's opinion, and instructed Mr. Henry Churchill, solicitor, to obtain such opinion. Churchill queried who was to pay for the opinion, the majority feeling being that those who lost ought to pay for it. "A good deal of feeling has been manifested by those who oppose the improvement, and an attempt has been made - most injudiciously - to stigmatise it as a dissenters' movement." Calcutt accused of intimidating one of overseers to give up the Rate Receipt Book. In the absence of the scrutiny, statement circulated giving a majority for Mr. Calcutt's proposition of 63 to 57 after discounting illegal votes.

Below correspondence between Mr. Calcutt and Rev. Brogden reproduced *in extenso*:

- letter (26 July 1854) from Calcutt, seeking meeting to discuss appropriate mode of enquiring into legality of votes cast;
- letter (26 July 1854) from Vicar that nothing to add to his previous advice at Vestry that he should seek legal advice, that Calcutt declined to call at his house to inspect rate book, and declining a meeting;
- letter (28 July 1854) from Calcutt, posing a series of questions - Did Brogden not instruct Churchill to take counsel's opinion; did Churchill not decline to act unless instructed by the parish officers; did not Churchill refuse to allow illegal votes until Brogden insisted contrary to his advice; when will legal advice be sought; is Brogden trying to evade making a legal and correct declaration of the poll ?

- letter (26 [sic] July 1854) from Vicar, headed "Close of the Correspondence", seeking to ridicule Calcutt, "a Protestant Dissenter of the parish", calling him "Sham Officer of the Pope" and "Grand Inquisitor of Deddington".

The press report concludes with the text of a handbill by Mr. Calcutt to the ratepayers of Deddington who voted in support of his motion. Vicar refusing to give straight answers. Cites law that disenfranchises ratepayers who fail to pay the poor rate, which was stated by Mr. Churchill at the time.
